IMPORTANT NOTICE

Effective January 3, 2011 Allegheny County's Division of Purchasing and Supplies implemented a new process for submitting bids.

This new process **requires that ALL** responses to an Invitation For Bid (IFB) must be submitted

electronically, the County will no longer accept paper (hardcopy) bids.

This change provides significant benefits to suppliers:

1. Additional time to prepare and submit bids.
2. The cost and time related to preparing bids will be reduced.
3. Postal or overnight delivery cost will be eliminated.
4. Suppliers will be able to view and edit their bid responses online up to the bid closing date and time.
5. Access the history of all of your bid responses online.
6. View Bid openings and results online. It will not be necessary to be physically present to witness bid openings.

Before you can use the new online system, you must first register on the Pennsylvania Purchasing

Group site for a unique PIN that will identify you and your company and will serve as your

electronic signature. To register, visit
