# CITY OF PITTSBURGH 2013 FIRE ALARM PERMIT

## Important Information for Alarm Applications – Please Read Carefully

1. The application must be filled out completely, using the same address to which any building permits for the property have been issued. The registered design professional information must be completed in its' entirety or the application will be rejected. The cost of work is required.
2. The application must be signed by the registered electrical contractor.
3. Three (3) sets of drawings are required at the time of application. At least one set must bear the **original seal** and **signature** of the designer; the other two must be **legible** copies.
4. Construction documents shall include, but not be limited to, all of the following:
  - ◆ A symbol legend
  - ◆ A riser diagram
  - ◆ A floor plan detailing the locations of all existing and proposed system components
  - ◆ Battery calculations (based on 60 hours of standby)
  - ◆ Conductor types and sizes
  - ◆ Voltage Drop calculations
  - ◆ Sequence of Operations description (including the type of evacuation for an alarm signal, total or selective)
  - ◆ Manufacturers, model numbers, and listing information for equipment, devices and materials, including candela ratings and decibel ratings of devices
  - ◆ Name of vendor for alarm equipment
  - ◆ An elevation or specification detailing the mounting heights of devices
