- \* All players must observe posted court and facility rules.
  
- \* All walk-in and flex-league players -without a Citiparks school tennis permit - are **limited to one (1) hour of play at a time per court, if there are players waiting.**
  
- \* Any special event, clinic, lesson, or league requires a Citiparks tennis permit.
  
- \* All tennis instructors must have a Citiparks tennis permit in order to reserve courts and/or conduct lessons or group clinics at Citiparks public tennis courts.
