When connection to a storm or combined sewer is required, prior to commencement of any repairs, an ACHD Plumbing Permit shall be obtained and noted in the space below. Additional permits may be required prior to any corrective actions.

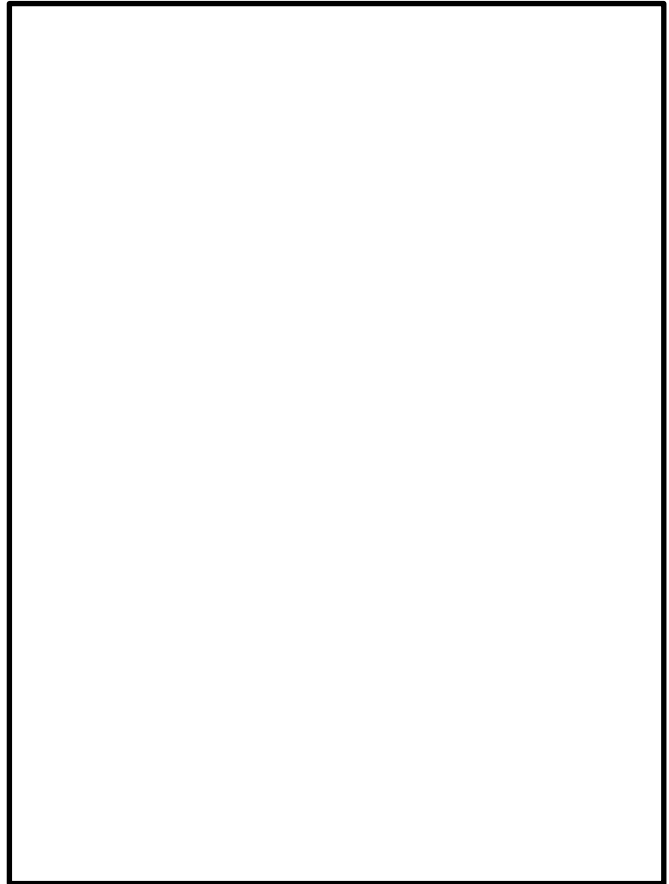
