 A **\$30.00** fee will be assessed for any check returned from the bank for any reason.

If you are employed within the City of Pittsburgh and your employer is **NOT** required or **WILL NOT** withhold the Local Services Tax, and you expect to make over \$12,000 in the City of Pittsburgh this year, you are required to pay the tax yourself using this form. Failure to file will result in the imposition of a penalty and interest charge.

You should pay **\$13 per quarter** for a total of \$52. Local Services Tax is \$52.00 per person, per year, payable quarterly. Pennsylvania law limits total payment by one person to a maximum of \$52.00 per year regardless of the number of employers in a year.

- First quarter (January, February, and March) return is due April 30.
- Second Quarter (April, May, and June) return is due July 31.
- Third quarter (July, August, and September) return is due October 31.
- Fourth quarter (October, November, and December) return is due January 31.
