Will new door look similar to other existing door?	Yes, it will be a simple door with same framework. The hardware will need to meet today's standards. It will be a single use door, not a double door.
New ATM and Surround?	Yes, new surround. The ATM will be the exact same ATM moving. The colorway (buffy) will remain the same.
Signage and branding?	Dollar Bank recently updated branding but it won't be anything on the exterior façade. There will be a DB logo and say ATM.

Lighting at ATM? Will that be brought up to current code?	Yes, it will.
We've approved the previous ATM relocation. Signage does require separate approvals.	We understand. Any current signs on building will remain the same in same location. The only change will be the security light at the machine.
Will size of logo on ATM remain the same?	Yes. We won't change any channel letters on building.
The logo is minimal so I don't see any issue.
